

THE CORPORATION OF THE TOWNSHIP OF STRONG
BY – LAW #2015-010
As Amended March 22, 2016
Being a By-law to prescribe a Tariff of Fees

WHEREAS Section 392, 394 (1) (2) and 400 of the Municipal Act, 2001 provides that the Council of a municipality may by by-law prescribe a tariff of fees.

NOW THEREFORE THE COUNCIL OF THE CORPORATION OF THE TOWNSHIP OF STRONG DOES HEREBY ENACT AS FOLLOWS:

1. The following is the Fee Schedule for General Government Charges for services:

j)	Interest charges – Road Closures/Taxes/Trailer Permits Landfill fees and Charges after 30 days. (per month)	1.25%
k)	NSF cheque returned by bank- administration fee	\$ 50.00
l)	Reissue a copy of a Tax Bill	\$ 20.00
m)	Building/Zoning Compliance Letter – administration fee	\$ 50.00
n)	Driveway Permits (\$50.00 admin fee retained) Deposit	\$ 300.00
o)	**Road Allowance-land Cost per sq ft	\$.50
p)	**Shore Road Allowance –land cost per sq ft	\$ 1.00
q)	Road Allowance/Shore Road Allowance Administration Fee	\$ 500.00
r)	Road Allowance/Shore Road Allowance Deposit	\$1500.00
s)	Minor Variance – Administration Fee	\$ 500.00

u)	Official Plan/Zoning By-law Amendment – Administration Fee	\$ 500.00
