**MUNICIPAL OPERATIONS
(updated May 29, 2020)**

The Township of Strong is making some operational changes to limit the spread of COVID-19 virus. **Certain Municipal Facilities will be CLOSED to the public from Tuesday, March 17 until Friday, July 6, 2020, unless otherwise posted (subject to change).**

To this effect, we are attempting to minimize physical contact with the public, so if you are able to conduct your business by email, telephone or at a later date, please proceed in this manner.

If you are experiencing flu like symptoms (coughing, fever, shortness of breath, chills) please stay home and do not visit any municipal facilities.

If you are experiencing any flu like symptoms, please contact Telehealth and/or the North Bay Parry Sound District Health Unit for assistance.

Municipal Facilities Affected:

- **Municipal Office** will be **CLOSED** to the public (including all public meetings). Staff will be in the office to assist residents by phone or email. Interest will be waived until July 31, 2020 and the dog license deadline of March 31 has been extended. There are many alternative methods of payment outlined on our website and a drop box has been placed in the vestibule (no cash, please) for drop offs during usual business hours.

- **Landfill Site #1 and Landfill Site #2** will remain **OPEN** to the public (subject to change), however please limit interactions with staff by following posted signage. There will be no payment of fees at the Landfill Site. The Re-Use Centre will be **CLOSED**. **The Almaguin Recycling Initiative has CANCELLED the May Household Hazmat Event.**
